COURSE INFORMATION

Aims of the Course

This course aims to provide the skills and knowledge required to an introductory level of competence as an in training crewman in the helicopter operational environment. These skills are taught by training in safely working in the aviation workplace, winching, health and security procedures and managing emergency situations in a helicopter.

Content of the Course

The course includes important background information, aviation theory and skill development in a range of aviation operations.

Theoretical and Practical subjects include:

- **Pre and Post Flight Preparation** – includes the importance of pre-flight preparation, briefing procedures and safe boarding techniques.
- **Personal Protective Equipment and Safety Equipment** – includes identifying and using common aviation PPE and helicopter safety equipment.
- **Emergency Procedures and Drills** – includes brace positions, personal response control, managing passengers and working with other crewmembers during an emergency, cockpit/cabin management and dealing with equipment failures.
- **Aircraft Underwater Escape Skills** – including development of an escape plan and the use of primary and secondary exits for escape from a submerged helicopter and sea survival skills.
- **Use of Life Saving Equipment** – includes knowledge on how to safely deploy life jackets and life rafts. This subject also covers how to safely board a life raft and life raft management.
- **Aviation Security Procedures** – includes aviation base and helicopter security procedures.
- **Helicopter Landing and Winching Procedures** – includes procedures for landing in prepared helicopter landing sites and unprepared landing sites. It also includes winching activities in a range of different situations



The competencies covered in the course includes:

- AVIF3005B – Maintain the safety of people and aircraft
- AVIF3006B – Respond to abnormal and emergency situations within the aircraft
- AVIF2014A – Undertake aircraft underwater escape and survival
- TLIO207D – Follow security procedures
- AVIW3025A – Complete aircraft/equipment pre- and post-flight actions
- AVIY3052A – Conduct Helicopter Landing Site and Unprepared Helicopter Landing Site operations

- AVIZ1005B – Maintain basic situation awareness in the aviation workplace
- PUAFIR209B – Work safely around aircraft
- AVIY4054A – Conduct hoisting operations

OR

- AVIW3024A – Perform Wireman Duties

- **Please note:** Due to the practical components of the course it is important that you advise us if you are **unable to swim, have a fear of water, fear of flying or confined spaces**. These issues will not prevent you from participating in the course but this will assist us to ensure your well being during training.

Qualification Pathways

At the successful completion of this course you will have gained 9 of the 14 competencies necessary for a Certificate III in Aviation - Rescue Crewman (AVI30510). CTS can provide extension courses that allow you to complete all the 14 required competencies of the Certificate III in Aviation (Rescue Crewman). We also offer the Certificate IV in Aviation - Aircrewman (AVI40610) that builds on to the competencies included in this course.

Assessment

To gain a nationally recognised Qualification or Statement of Attainment, students need to demonstrate competence in both the skill and knowledge requirements of this course. This assessment will be conducted through observing skills during practical flying sorties and ground based activities.

Knowledge of the theoretical components of the course will be assessed through the use of written questionnaires. Both assessments will be conducted at the end of each component of training. Notification of results will be given at the completion of that segment of the training.

Recognition of Prior Learning

RPL can be gained in the competencies in this course. If you wish to apply for any competency contained in this course or the full qualification please ask our Training Coordinator for an RPL Assessment Kit and application form.

Course Duration, Location and Dress Code

The course is a full time course conducted over TEN (10) days. The course starts promptly at 8am each morning at the HEMS Academy unless otherwise advised by your instructor. Some practical training will take place at Careflights Bilinga Air Base. You are expected to arrive suitably dressed for the scheduled training for each day. If flying is being undertaken as part of the days training you are expected to arrive in a flying suit and flying boots . These will need to be supplied by yourself or your company. On non-flying days neat, clean casual dress is required. Your instructor will inform you at the end of each day as to the location of training and the activities that will be undertaken on the following day. Most days training will be completed at 5pm.

COURSE COST AND REFUND POLICY

The cost for the Introductory Crewman Course is \$12,500 AUD. Course costs include training manuals (some are contained on CD/or USB), all practical demonstration aids, all tuition and flying time. There is four hours flying time included in your course cost. This flying is undertaken in a winch equipped AS350 (Squirrel) helicopter. You will need to provide your own morning tea and lunch. To secure a place on a nominated course you will need to provide payment in full ten working days prior to course commencement. Payment Plans can be organized for you if required.

Late enrollments will be accepted if vacant positions on the desired course are available. Late enrollments will need to be paid in full at time of booking the course.

For organisations who wish to book a course for a minimum of 4 participants, a 50% booking payment will be required. Group discounts do apply and clients are invited to enquire about these at the time of booking. Group courses can be scheduled to suit the individual needs of the organisation. The final 50% payment will be required at the completion of the training course.

Available payment methods include credit card, cheque and electronic funds transfer (EFTPOS). Payment details will be provided when course bookings are made.

Refund Terms

Cancellations must be received by CareFlight Training Services via email or in writing within **seven** working days of the course commencement date. Another participant may be nominated to fill the booked position in the event of cancellation. If another participant is not nominated in the event of cancellation, a refund of the course cost minus 15% for administration costs will be given if CareFlight Training Services is notified within **seven** working days.

If notification is not given within seven working days of the commencement of the course unfortunately no refund is available.

If training has commenced in the Introductory Crewman Course, no refund is available to participants who leave before completing the course unless the student can provide a medical certificate or show extreme personal hardship. However, should participants wish to finalise incomplete competencies in a future course, the original fee payment can be used as credit towards that course within six months of initial payment.

If CareFlight Training Services is unable to deliver the course for any reason participants will be notified within five working days of the course commencement. Participants will be offered an alternative date to attend the course. If the alternative date is not suitable the course cost will be refunded in full.
